

Year-End Estimated Distribution Information for Cohen & Steers Open-End Funds

The table below lists the Cohen & Steers open-end mutual funds that are anticipated to make taxable distributions of ordinary income and capital gains in December 2023. These estimated distribution per share amounts are based on portfolio information as of October 31, 2023, and do not include all required tax adjustments. **Estimated range of distributions are as of October 31**, 2023 and are subject to change without notice prior to the record date and therefore, actual distributions may be more or less than these estimates.

Shareholders should remember that the net asset value of an open-end fund with an ordinary income and/or capital gain distribution will decline on the ex-dividend date to reflect the adjusted net asset value of the fund after the distribution.

All Cohen & Steers Open-end Funds except Cohen & Steers Alternative Income Fund, Inc, Cohen & Steers Preferred Securities and Income Fund, Inc., and Cohen & Steers Low Duration Preferred and Income Fund, Inc., will make their distributions on December 7th, 2023 to shareholders of record on December 6th, 2023, with an ex-dividend date of December 7th, 2023.

Each of Cohen & Steers Alternative Income Fund, Inc., Cohen & Steers Preferred Securities and Income Fund, Inc., and Cohen & Steers Low Duration Preferred and Income Fund, Inc. will make its distributions on December 14th, 2023 to shareholders of record on December 13th, 2023, with an ex-dividend date of December 14^h, 2023.

Cohen & Steers expects to update the estimated distribution range for each fund periodically. Actual distributions will be announced on the payable date for each fund.
